**Subject: Conduct of Registrar Court in Goods and Services Tax Appellate Tribunal,
Hyderabad Bench from 20.04.2026 - reg**


It is hereby notified for general information of all stakeholders—including taxpayers, departmental authorities, authorized representatives, advocates and other concerned parties—that the Hyderabad Bench of the Goods and Services Tax Appellate Tribunal (GSTAT) has formally commenced its operations. The temporary office address of the Hyderabad Bench, GSTAT, is:

"3rd Floor, GST Bhavan, LB Stadium Road, Basheerbagh, Hyderabad, Telangana - 500004"

2. The Hyderabad Bench shall exercise jurisdiction over the Telangana State as notified by the Department of Revenue vide notification no S.O. 5063(E) dated 26.11.2024 and shall hear appeals filed under the provisions of the CGST Act, 2017, the Integrated Goods and Services Tax Act, 2017 and the Telangana Goods and Services Tax Act, 2017, as applicable, arising from the above-mentioned jurisdictions.
3. As per Rule 24 of GSTAT Procedure Rules, if a party fails to rectify the defects raised in the defect notice, within 7 days, the same shall be placed before the Registrar, who, on sufficient cause, may allow such reasonable time to the party, in any case not exceeding 30 days.
4. It has been observed that appeals are being filed with numerous defects in respect of basic procedural matters, particularly relating to court fees, documentation etc. Accordingly, the Registrar Court will be convened from the forthcoming week onwards, commencing from 20.04.2026 at 11:30 AM at the above-mentioned premises.
5. Daily cause list will be issued one day prior to the listing of the case. An e-mail will be sent to the Taxpayers/ Jurisdictional AC/DCs (appellants) and Tax practitioners' association, of the same, till the website is functional. So, all the stakeholders are requested to keep track of their cases and attend the Registrar Court for rectification of defects.

6. Trade and Industry Associations / Chambers of Commerce / Authorised Representatives / Tax Bar Associations / Legal Practitioners are requested to disseminate the contents of this Public Notice among their members.
