The GSTAT Andhra Pradesh state bench at Vijayawada shall take up appeals pertaining to the Vijayawada Bench and Visakhapatnam Bench with discretion of the Vice-President GSTAT Andhra Pradesh to hear the matters through virtual or hybrid or physical mode.

6. The procedural framework for the institution of appeals is governed by *Chapter III of the Goods and Services Tax Appellate Tribunal (Procedure) Rules, 2025*. For the guidance/convenience of all concerned, the e-filing Advisory, the Goods and Services Tax Appellate Tribunal (Procedure) Rules 2025 and various orders issued by the Tribunal from time to time have been made available and accessible on the GSTAT Portal (<https://efiling.gstat.gov.in>) under the "NOTICE" section.
