11.07.2026	GSTR – 1: GST Filing of monthly Statement of Outward Supplies by a registered person with aggregate turnover exceeding INR 5 Crores during the preceding financial year or any registered person has opted to file a monthly return.	June 2026
13.07.2026	GSTR – 1 IFF: Details of B2B Supply of a registered person with turnover less than INR 5 Crores during the preceding year and who has opted for quarterly filing of return under QRMP.	April – June 2026
13.07.2026	GSTR – 6: Details of Input Tax Credit (ITC) received and distributed by an Input Service Distributors (ISD).	June 2026
13.07.2026	GSTR – 5: Summary of outward taxable supplies and tax payable by a non-resident taxable person.	June 2026
18.07.2026	CMP-08: Quarterly challan-cum-statement to be furnished by composition taxpayers.	April – June 2026
