PUBLIC NOTICE - 02/2026

Sub: Functioning of the Goods and Services Tax Appellate Tribunal, State Bench, Dehradun - reg.

The Goods and Services Tax Appellate Tribunal (GSTAT), has been constituted by the Central Government to hear appeals preferred against the orders passed by the Appellate Authority or the Revisional Authority under section 107 or section 108 of the Central Goods and Services Tax Act, 2017 or the State Goods and Services Tax Act, 2017 or the Union Goods and Services Tax Act, 2017, as the case may be.

2. The GSTAT has its Principal Bench at New Delhi and 31 State Benches located in various States and Union Territories [as notified by the Department of Revenue vide S.O.3048(E) dated 31.07.2024, and subsequently modified vide S.O.5063 (E) dated 26.11.2024].

3. One of the State Benches of the GSTAT is Dehradun Bench having its jurisdiction over all districts in the State of Uttarakhand. Within the said jurisdiction, the Dehradun Bench shall hear appeals against the orders passed by the Appellate Authority or the Revisional Authority under section 107 or section 108 of the Central Goods and Services Tax Act, 2017 or the State Goods and Services Tax Act, 2017 or the Union Goods and Services Tax Act, 2017, as the case may be.

4. The Dehradun Bench is operating from its permanent location at the following address:

5. The appeals to be filed in the Dehradun Bench must strictly adhere to the relevant provisions of the Goods and Services Tax Appellate Tribunal (Procedures) Rules, 2025, notified by the Central Government for regulating the procedures and functioning of the GSTAT and in conjunction with all other prevailing statutes, regulatory framework and administrative directives issued periodically. The concerned stakeholders may visit the 'Notice' section of the GSTAT portal (<https://efiling.gstat.gov.in>) for e-filing advisory, the Goods and Service Tax Appellate Tribunal (Procedures) Rules, 2025 and the other relevant orders.

Further, any technical issues may be reported by clicking on the '**Report any issue**' button under the '**Help Center**' section [of the GSTAT Portal] and submitting the duly field in '**Incident Report Form**'.
